Minimum average annual construction turnover of the best 3 years within the last 10 years: Nrs. 5,30,00,000.00

(without VAT).

- Minimum work experience of similar size and nature: One (1) Project with a value of NRs.3,75,00,000.00(Without VAT).

Bidders submitting their bid electronically should deposit the cost Nrs. 5000.00 as a non refundable fee of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. - The bids will be opened in the presence of Bidders' representatives who choose to attend at 2074/11/08 (20th February, 2018), 14:00 at the office of Budhanilakantha Municipality, Office of Municipal Executive, Kathmandu, Province No. 3, Nepal. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a scanned copy of the bid security in pdf format, amounting to a minimum of Nrs. 11,25,000.00, which shall be valid for 30 days beyond the validity period of the bid.
- 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- If the specified date for last date of submission & opening falls on a government holiday then the same time on the next working day shall be considered for such events. In such case the validity of bid security shall be considered from already specified last dates for bid submission.
- Each bidder shall bid only one bid, either individually or as a partner in a J/V. To facilitate contract administration, the number of partners in J/V is limited to three.
