The Budhanilakantha Municipality, Office of Municipal Executive has allocated funds towards the cost of project "Construction of Municipality Office Building, Phase II" and intends to apply part of the funds to cover eligible payments under the Contract for Construction of Municipality Office Building, Phase II. Bidding is open to all eligible Nepalese Bidders.
2. Budhanilakantha Municipality, Office of Municipal Executive invites **Single Stage Two Envelope Electronic Bids** from eligible bidders for the construction of Municipality Office Building, Phase II under national competitive bidding procedures. Only eligible bidders with the following key qualifications should participate in this bidding:
Minimum average annual construction turnover of the best 3 years within the last 10 years: Nrs. 5,30,00,000.00 (without VAT).
3. Minimum work experience of similar size and nature: **One (1) Project** with a value of **Nrs.3,75,00,000.00(Without VAT)**. Eligible Bidders may obtain further information and inspect the bidding documents at the office of Budhanilakantha Municipality, office of Municipal Executive, Golphtar, Kathmandu Province no. 3, Nepal. 4. Bidder shall download the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np/egp. Bidders submitting their bid electronically should deposit the cost Nrs. 5000.00 as a non refundable fee of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 5. Pre-bid meeting shall be held in the Office of Municipal Executive, Budhanilakantha Municipality at 12:00 noon of 2074/10/26. (09 February, 2018)
6. Electronic bids must be submitted to the office through PPMO website www.bolpatra.gov.np/egp on or before 12:00 on 2074/11/08(20th Feb, 2018. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2074/11/08 (20th February, 2018) . 14:00 at the office of Budhanilakantha Municipality, Office of Municipal Executive, Kathmandu, Province No. 3, Nepal. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a scanned copy of the bid security in pdf format, amounting to a minimum of Nrs. 11,25,000.00, which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. If the specified date for last date of submission & opening falls on a government holiday then the same time on the next working day shall be considered for such events. In such case the validity of bid security shall be considered from already specified last dates for bid submission.
10. Each bidder shall bid only one bid, either individually or as a partner in a J/V. To facilitate contract administration, the number of partners in J/V is limited to three.
11. The bidders are advised to visit the site & assess the actual site condition before submission of bid document.
12. The employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
13. All other terms & conditions will be as per prevailing procurement act & regulations of government of Nepal & local body financial administrative regulation.
